

WIN DAVE'S SEATS TICKET GIVEAWAY

OFFICIAL RULES

Participants will enter for a chance to win four (4) tickets to attend the Coachella Valley Firebirds vs Bakersfield Condors match on Saturday, February 18, 2023 at Acrisure Arena in Palm Desert, CA (estimated total retail value \$340.00 USD).

WHEN IS THIS HAPPENING?

The Giveaway commences at 11:00am Pacific Time on February 7, 2023 and ends at 10:00am Pacific Time on February 16, 2023 (the “Giveaway Period”).

HOW TO ENTER

To enter, simply visit <https://cvfirebirds.com/win-daves-seats> and submit an entry by providing your full name, date of birth, phone number, email address, zip or postal code, and any other information that may be required. Participants must provide all requested information to enter; incomplete or inaccurate entries will not be eligible to win. Entry materials/data that have been tampered with or altered, or mass entries or entries generated by a script, macro or use of automated devices are void.

By participating in this Giveaway and/or claiming a Prize should you be selected as a Winner, you certify that you are at least 18 years old and a legal resident of the continental United States, and agree to these Official Rules and SHP’s Terms of Use and Privacy Policy.
